Dem Party Leaders, Pfizer, Moderna Involved in US Biological Activities in Ukraine- Russian MoD

The Russian military began reporting on the extent of US military biological activities in Ukraine in March, citing seized documents and other materials on the study of a range of potentially deadly bioweapon agents, including diseases which can be spread naturally using local geography, flora and fauna, and target certain ethnic groups.


Senior Democratic Party politicians are the chief "ideologists" of America's illegal operations in biolabs operating throughout Ukraine, and have involved major multinational biotech companies in their activities, Igor Kirillov, the head of Russia's Radiation, Chemical, and Biological Defence Troops, has indicated.

Speaking at a briefing in Moscow on Wednesday and citing an MoD analysis of documentary evidence, the RCB Troops chief said the profits US politicians earn for the private biotech sector helps to pay for their re-election via campaign donations.

According to Kirillov, the US executive branch has also worked to create a "legislative framework to finance military biological research directly from the federal budget", and with funds of non-government organisations underwritten by the state and controlled by the leadership of the Democratic Party, including charitable foundations affiliated with the Clinton family, the Rockefellers, George Soros, and Hunter Biden.

Major global pharmaceutical companies have become involved in these shady "public-private" partnership schemes, including Pfizer, Moderna, Merck, and Pentagon-affiliated biotech firm Gilead, Kirillov said.

"US specialists are working [in Ukraine] on the testing of new medicines, bypassing international safety standards. As a result, Western companies seriously reduce the costs of research programmes and gain significant competitive advantages", the officer said.





State Structures' Involvement

Ukrainian state structures are also involved in the US-funded and organised military biological activities in their country, Kirillov said, with Kiev's main job being "to conceal illegal activities, conduct field and clinical trials and provide the necessary biomaterial".

In 2020, Kirillov said, an attempt was made to infect the residents of the settlement of Stepovoye in the Lugansk People's Republic with a multi-drug-resistant strain of tuberculosis using counterfeit banknotes contaminated with the disease's causative agent and spread among local youth.

Additionally, the RCB Troops chief said that his agency has received information detailing the Pentagon's experiments on Ukrainian nationals at Psychiatric Hospital No. 1 in the village of Strelechie, Kharkov region, with the research targeting male patients aged 40-60 with a high stage of physical exhaustion, and overseen by a US national.

The Russian military operation in Ukraine has stopped the spread of US military activities in Ukraine, and halted these "criminal experiments" on its civilian population, Kirillov stressed.

In the case of the research taking place at the Kharkov mental hospital, Western specialists were evacuated in January 2022, and the equipment and pharmaceutical preparations involved relocated to western Ukraine, he said.

Polish specialists have also been working with Ukraine's biolabs, Kirillov said, citing documents detailing the work of the Polish Institute of Veterinary Medicine and the US' Battelle Memorial Institute - a Pentagon contractor - on research assessing epidemiological threats and the spread of the rabies virus in Ukraine.

"In addition, documentary evidence has been obtained about Poland's funding of Lvov Medical University, which includes a participant in US military biological projects - the Institute of Epidemiology and Hygiene. Since 2002, this organisation has been implementing a retraining programme for specialists with experience working with dual-use materials and technologies", the officer said.




Fig. 5. Spatiotemporal clustering of rabies cases in foxes (red circles) and domestic carnivores (blue circles) from 2012 to 2018 were detected using space-time permutation model in SaTScan.

The majority (7/10) of the clusters in foxes and one cluster (1/3) in domestic carnivores coincides with high kernel density locations. These overlapping areas are indicated in the Table 3 and Table 4.

The number of samples from foxes (Fig. 6) and domestic carnivores (Fig. 7) show the monitoring efforts in Ukraine. With regards to foxes data, the majority of oblasts provided a moderate to a high number of samples. Only in few oblasts monitoring efforts/year were more intense (-1000-2000 samples per oblast) (Fig. 6).

The German military has also been involved in research in Ukraine, Kirillov said, citing documents indicating that the Bundeswehr's Institute of Microbiology had taken some 3,500 blood serum samples from 25 Ukrainian regions back to Germany between 2016 and 2019. The officer said the Institute's as

yet unidentified interest in these biomaterials "raises questions about the goals [being] pursued" by the German Armed Forces.

Отже, попередній проект передбачав вивчення розповсюдженості збудника Крим-Конго геморагічної гарячки серед здорових осіб в Україні. В рамках проекту відібрано близько 3500 зразків сироваток від здорових осіб, що мешкають на території 25 областей, тестування яких триває і сьогодні. А тому німецькою стороною було прийнято рішення про продовження співпраці, а також додалось тестування зазначених зразків з метою визначення збудника хантавірусної інфекції.

Під час виконання проекту факівці провідної в Німеччині установи, де розташована одна з 4-х лабораторій Німеччини рівня ВВL-4, га на базі якої функціюнує Центр, що співробітничає з ВООЗ з питань лабораторної діагностики арбовірусних і геморагічних гарячок, та Референс-центр Німеччини для імпортованих паравитарних та вірусних інфекцій, відвідували вірусологічну референс-лабораторію з метою проведення навчань та тревінії вірусологічну референс-лабораторію з метою проведення навчань та тревінії і пабораторії ЦГЗ МОЗ сертифікати про проходження відповідної підготовки подо визначення високопатогенних вірусів, зокрема Крим-Конго, Ебола, Зіка, Демге, Західного Ніпу, Чикунгунья, клішового енпефаліту та івших збудників ів використанням сучасних методів діагностування, включаючи метод полімеразної ланшогової реакції, імуноферментного, імунофлюоресцентного методу та імуноблоту.

Крім візитів німецьких колег, за рахунок фінансування в рамках проекту, здійснено візити до Інституту тропічної медицини з метою вивчення сучасних методик та участі в семінарах, які проводились на базі інституту під час проходження підготовки.

За ракунок фінансування вказаного проекту німецькою стороною закуповувалися та поставлялися до вірусологічної лабораторії нашої установи тест-системи з метою пабораторної діагностики в Україні різними методами таких особливо небезпечних вірусних інфекцій, як:

- Крим-Конго геморагічна гарячка (ПЛР, ELISA, імунофлюоресцентний аналіз);
 - Ебола (ПЛР);

- хантавірусна інфекція (імуноблот, ELISA, імунофлюоресцентний аналіз);
 Денге (ELISA, імунофлюоресцентний аналіз, імунохроматографічний
 - денге (сслья, імунофлюоресцентний аналіз, імунохроматографічний із);
 - Чикунгунья (ELISA, імунофлюоресцентний аналіз, імуноблот);
 гарячка Західного Нілу (ELISA, імунофлюоресцентний аналіз);
 - кліщового енцефаліту (ELISA, імунофлюоресцентний аналіз).

Отже, за результатами співпраці тепер в Україні існує можливість підтвердження випадків зазначених інфекційних захворювань на сучасному світовому рівні.

В рамках фінансування проекту німенькою стороною було закуплено необхідні витрагні матеріали для вірусологічної лабораторії на суму 4000 СВРО : 3000 СВРО у 2016 ропі і 1000 СВРО у 2017-2018 ропі, 6000 СВРО - 2021 ропі, а також кріосудини на 2,0 мл; рукавички нитрилові; халати одноразові лабораторні 3-х кольорів, стрічки індикаторні для автоклавів; піпетки серологічні, флакони типу "епендорф", дезінфікуючий засіб для обробки поверхонь, дезінфікуючий засіб для обробки поверхонь, дезінфікуючий засіб для обробки рук; набір для екстракції нуклеїнових кислот на 250 зразків; накінечники для дозаторів на 200 мкл та 1000 мкл та інше.

В рамках проекту вірусологічна референс-лабораторія ЦГЗ МОЗ пройшла раунд зовнішнього незалежного опінювання якості досліджень. А саме отримано та досліджень двола методами (ППР та інумофлюореспентник) 4 кодованих зразки сироваток крові з метою визначення діатностичних титрів ангитіл у кодованих сироватаха. Вирішення контрольних задач, виданих Інститутом тропічної медицини з метою оцінки якості досліджень щодо збудника Крим-Конго геморатічної гарячки, видвилось успішним - у 100 % результати вимачено правильно.

Спід зазначити, що в рамках фінансування Міністерством закордонних справ Німеччини вказаного проекту, відбувається вивчення англійської мови (2 рази на тиждень, з березня 2018 по грудень 2018) фахівцями вірусологічної референс-лабораторії (4 особи: 3 пікарі-вірусологи та 1- лаборант), а також одного епідеміолога з питань епіднагляду за ОНІ.

Отже, в рамках фінансування проекту існує можливість:

- постановки діагнозу шляхом визначення етіологічного фактору щодо актуальних для України особливо небезпечних інфекцій, що дозволило покращити реєстрацію геморагічних гарячок в Україні; лабораторно підтверджено випадки гарячки Західного Нілу, гарячки з нирковим синдромом (хантавірусна інфекція); гарячка Денге; гарячка Чикунгунья;
- проведення серомоніторингових доспіджень з метою вивчення розповсюдження збудника Крим-Конго геморагічної гарячки та хантавірусної інфекції серед здорових осіб на території України;



According to the MoD's information, along with the Munich-based Institute of Microbiology, the Berlin-based Robert Koch Institute, the Loffler Institute in Greifswald, and the Nocht Institute of Tropical Medicine in Hamburg are also participating in biological research activities in Ukraine.

Mariupol Samples Partially Recovered

An RCB Troops investigation of samples from a veterinary laboratory in Mariupol has concluded that it also may have been involved in the broader US-led biological research activities, Kirillov said, pointing to the presence of pathogens uncharacteristic of veterinary diseases, such as typhoid fever, paratyphoid fever, and gas gangrene at the lab [editor's note, also cholera, diphtheria, pneumonia, tularemia, anthrax and several species of human dysentery]. Part of the lab's collection of samples was destroyed on 25 February, but due to the rush, some of it has been preserved intact, and is now being analysed by Russia.

"To ensure safety and safe storage, Russian specialists exported 124 strains and have organised their study", Kirillov said.



The officer also revealed that Russian specialists have carried out work "directly in two biological laboratories in Mariupol", and that "evidence has been obtained of the emergency destruction of documents confirming their work with the US military. A preliminary analysis of the surviving documentation indicates that Mariupol was used as a regional centre for the collection and certification of the cholera pathogen", with the samples sent to the Centre for Public Health in Kiev, which transferred the materials on to the United States.

Kirillov stressed that the information that continues to be gathered and analysed by the Russian MoD casts doubt on assurances by US specialists that Ukraine does not have the capability to develop and

produce bioweapons, and that the US itself has not "found" any evidence of biological weapons in Ukraine.

WMD Provocations Possible

The RCB Troops chief also indicated that Moscow has intelligence related to the preparation of possible provocations involving weapons of mass destruction in Ukraine to accuse the Russian military of using such arms along a "Syrian-style" scenario, in which the necessary evidence is fabricated and the "perpetrators" are appointed ahead of time.



One piece of evidence suggesting the high likelihood of such provocations taking place is Kiev's request in a letter to European Union officials for personal protective equipment that provides protection against toxic chemicals and biological agents, Kirillov said.

The supply of organophosphate toxicity medications to Ukraine is also a concern for the Russian military, the officer noted, pointing out that in the first months of 2022, over 220,000 ampoules of atropine, as well as medicines for treatment and disinfection following a chemical attack, have been delivered to Ukraine by the United States.

Additionally, Kirillov said, 10 more drones equipped with 30-litre containers and spraying equipment were found in the town of Kakhovka, Kherson region in late April, on top of three others with similar equipment found in the Kherson region in March.

Kirillov's RCB Troops have spent over two months investigating <u>and reporting on</u> the US-sponsored military biological activities taking place at 30 separate facilities across Ukraine going back to at least 2005.

Western officials and media have largely dismissed the information provided as a "conspiracy theory", notwithstanding Under Secretary of State Victoria Nuland's <u>admission</u> at a Senate hearing in March

that "biological research facilities" do in fact exist in the Eastern European country and that the US was "working with" the Ukrainians to ensure that these materials "do not fall into the hands of Russian forces". Investigations by the few Western outlets that have conducted their own research have confirmed individual details of the Russian MoD's allegations - such as Hunter Biden's role in securing millions of dollars in funding for a US contractor working in Ukraine.

Russian MOD summary briefing

Briefing on the results of the analysis of documents related to the military biological activities of the United States on the territory of Ukraine

May 11, 2022

The Russian Defence Ministry continues to study materials on the implementation of military biological programs of the United States and its NATO allies on the territory of Ukraine.

We have already mentioned Robert Pope, director of the Cooperative Threat Reduction Programme and author of the idea of the Central Depository of Highly Dangerous Microorganisms in Kiev.

In his statement of April 10, 2022, Pope said that "...there is no reason to claim that research related to the development of biological weapons is taking place in Ukraine...". He previously claimed that "...the Americans did not find biological weapons when they first started working with Ukraine, and they still haven't. In addition, Ukraine lacks the infrastructure to develop and produce biological weapons...".

I would like to recall that the term "biological weapons" includes biological formulations that contain pathogenic micro-organisms and toxins, as well as the means of delivery and use of said formulations.

While the priority for Ukrainian healthcare is socially significant diseases such as HIV, poliomyelitis, measles and hepatitis, US customers are interested in a completely different nomenclature: cholera, tularemia, plague and hantaviruses.

As a result of the special military operation on the territory of Ukraine, facts of work with the specified pathogens, which are potential agents of biological weapons, have been revealed. At the

same time, it was noted that Ukraine had sent a request to the manufacturing company regarding the possibility of equipping the Bayraktar drones with aerosol equipment.

In addition on March 9, three unmanned aerial vehicles equipped with 30-litre containers and equipment for spraying formulations were detected by Russian reconnaissance units in Kherson region. At the end of April, 10 more were found near Kakhovka.

All this information calls into question the statements of American experts.

We have previously provided a scheme for US coordination of biological laboratories and research institutes in Ukraine. Its preliminary analysis suggests that Ukraine is essentially a testing ground for the development of biological weapons components and the testing of new samples of pharmaceuticals.

The Russian Ministry of Defence was able to clarify the said scheme.

It should be noted that the ideologues of US military-biological activities in Ukraine are the leaders of the Democratic Party.

Thus, through the US executive branch, a legislative framework for funding military biomedical research directly from the federal budget was formed. Funds were raised under state guarantees from NGOs controlled by the Democratic Party leadership, including the investment funds of the Clintons, Rockefellers, Soros and Biden.

The scheme involves major pharmaceutical companies, including Pfizer, Moderna, Merck and the US military-affiliated company Gilead. U.S. experts are working to test new medicines that circumvent international safety standards. As a result, Western companies are seriously reducing the cost of research programmes and gaining a significant competitive advantage.

The involvement of controlled nongovernmental and biotechnological organisations, and the increase in their revenues, allows the leaders of the Democratic Party to generate additional campaign finance and hide its distribution.

In addition to US pharmaceutical companies and Pentagon contractors, Ukrainian state agencies are involved in military bioweapons activities, whose main tasks are to conceal illegal activities, conduct field and clinical trials and provide the necessary biomaterial.

Thus, the US Department of Defence, using a virtually internationally uncontrolled test site and the high-tech facilities of multinational companies, has greatly expanded its research capabilities, not only in the field of biological weapons, but also in gaining knowledge about antibiotic resistance and the antibodies to specific diseases in populations in specific regions.

It should be noted that not only the US, but also a number of its NATO allies are implementing their military-biological projects in Ukraine.

The German government has decided to launch a national biosafety programme independent of Washington, D.C., starting in 2013. Twelve countries, including Ukraine, are involved in the Programme.

On the German side, the programme involves the Institute for Armed Forces Microbiology (Munich), the Robert Koch Institute (Berlin), the Loeffler Institute (Greifswald) and the Nocht Institute for Tropical Medicine (Hamburg).

New documents reveal that between 2016 and 2019 alone, three and a half thousand blood serum samples of citizens living in 25 regions of Ukraine were taken by military epidemiologists from the Bundeswehr Microbiology Institute.

The involvement of institutions subordinate to the Bundeswehr confirms the military orientation of biological research carried out in Ukrainian laboratories and raises questions about the goals pursued by the German armed forces in collecting biomaterials of Ukrainian citizens.

The documents obtained also show the involvement of Poland in Ukrainian biolaboratories. The participation of the Polish Institute of Veterinary Medicine in research aimed at assessing the epidemiological threats and spread of the rabies virus in Ukraine has been confirmed. Characteristically, the research in question was carried out jointly with the US-based Battelle Institute, a key contractor for the Pentagon.

In addition, Polish funding for the Lvov Medical University, which includes a member of US military biology projects, the Institute of Epidemiology and Hygiene, has been documented. The organisation has been running a retraining programme for specialists with experience of working with dual-use materials and technologies since 2002.

The special military operation by Russian troops succeeded in obtaining additional information about bio-incidents in Ukraine.

For example, materials indicating the intentional use of a multidrug-resistant tuberculosis pathogen in 2020 to infect the population of the Slavyanoserbsky district of the LPR were examined.

The flyers, made in the form of counterfeit currency notes, were infected with the tuberculosis agent and distributed to minors in Stepovoe village. The organisers of this crime took into account

the behaviour of children, who have a habit of "putting everything in their mouths" and taking food with unwashed hands.

The results of bacteriological studies have confirmed the resistance of the isolated bacteria to firstand second-line anti-TB drugs, meaning that the disease caused by them is much more difficult to treat and the cost of treatment is much higher.

According to the conclusion of the Lugansk Republican Sanitary and Epidemiological Station, "...the contamination of the notes was most likely carried out artificially, as the material contains extremely dangerous strains of the pathogen in concentrations capable of ensuring infection and development of the tuberculosis process...".

In his conclusion, the chief doctor of the Lugansk Republican TB Dispensary also notes that "...there are all signs of deliberate, man-made contamination of the flyers with highly pathogenic biomaterial...".

We previously reported on trials of potentially dangerous biological drugs on one of the least protected categories of people - patients of the Kharkov Regional Clinical Psychiatric Hospital No 3.

We have received new information revealing details of the Pentagon's inhuman experiments on Ukrainian citizens in Psychiatric Hospital No 1 (Streleche village, Kharkov region). The main category of subjects was a group of male patients aged 40-60 years with a high stage of physical exhaustion.

In order to conceal their US affiliation, the biological research experts travelled via third countries. Here is a photograph of Florida native Linda Oporto, who was directly involved in these works.

In January 2022, the foreign nationals conducting the experiments were evacuated in an emergency and the equipment and drugs they were using were taken to western Ukraine.

Russian Defence Ministry specialists have carried out work directly in two biolaboratories in Mariupol.

Evidence of emergency destruction of documents confirming work with the US military establishment was obtained. A preliminary analysis of extant documentation indicates the use of Mariupol as a regional centre for cholera pathogen collection and certification. The selected strains were sent to the Public Health Centre in Kiev, which is responsible for the onward shipment of biomaterials to the United States. These activities have been carried out since 2014, as evidenced by the transfer of strains.

An act of destruction of the pathogen collection dated February 25, 2022, according to which cholera, tularemia and anthrax pathogens were handled there, was found in the sanitary and epidemiological laboratory.

Part of the collection of the veterinary laboratory was not destroyed in a hurry. In order to ensure safety and secure storage, 124 strains were exported by Russian specialists and their study was organised.

The presence in the collection of pathogens that are uncharacteristic of veterinary medicine, such as typhoid, paratyphoid fever and gas gangrene, is a cause for concern. This could indicate the laboratory's misuse and involvement in a military biological programme.

We will continue to examine the full volume of material received from the Mariupol biolaboratories and will inform you about the results.

The Russian Ministry of Defence has information that provocations are being prepared to accuse the Russian Armed Forces of using weapons of mass destruction, followed by a "Syrian scenario" investigation to fabricate the necessary evidence and assign blame.

The high likelihood of such provocations is confirmed by requests from the Kiev administration for personal skin and respiratory protection equipment that provides protection against toxic chemicals and biological contaminating agents. The supply to Ukraine of organophosphorus poisoning antidotes raises concerns. In 2022 alone, more than 220,000 ampoules of atropine, as well as preparations for special treatment and disinfection, were delivered from the USA at the request of the Ukrainian Ministry of Health.

Thus, the information obtained confirms that the United States is implementing an offensive military-biological programme in Ukraine to study the possibility of forming controlled epidemics in specific territories.

The special military operation of the Russian Armed Forces has crossed the US military-biological expansion in Ukraine and stopped criminal experiments on civilians.
